

Legal and Regulatory Compliance Practices

Inova Solutions must conduct its business interactions and activities in full compliance with the applicable (international) laws and regulations, including complying with all applicable corporate and tax laws and trade laws: export, re-export and import (international) and regulations controls. Inova Solutions must also conduct its business interactions and activities with full compliance of antitrust and fair competition laws that govern all jurisdictions in which it operates and will participate in international boycotts that are sanctioned by the United States of America Government and/or the European Community Government and/or applicable laws and regulations. Finally, Inova Solutions must adhere to and comply with all international laws and regulations regarding anti-corruption and anti-money laundering.

Business Practices

Inova Solutions People shall not interact and/or deal <u>directly</u> with any Vendor and or Supplier or Client of Inova Solutions whose spouse/partner/companion or other family and or relative holds a significant interest in the Vendor or Supplier or Client. In the course of the negotiations any and all agreements with the Supplier or Vendor or Client must be dealt with by another representative of Inova Solutions since dealing directly with a Vendor's or Supplier's or Client's spouse/partner/companion or other family or relative employed by Inova Solutions is strictly prohibited;

(iv) insider trading by not buying or selling Inova Solutions or another company's securities when in possession of information about Inova Solutions or another company that is not available to the investing public and that could influence an investor's decision to buy or sell the security must be avoided at all times by all Inova Solutions People.

Honesty and Ethical Conduct
